

Application for Financial Assistance

Hurricane Florence Recovery

First Presbyterian Church (FPC) received several donations to be used for assisting victims of Hurricane Florence. We will accept a limited number of applications for financial assistance from FPC members.

Due Date: Grant applications must be returned to Connie in the church office by April 31, 2019.

Type of Assistance

Assistance is available to qualified applicants towards damage or losses caused by Hurricane Florence in September 2018. The initial financial grant is up to a maximum of \$2,500 per applicant/household/address and is intended to deal with a portion of losses not covered by another means. Total grants will not exceed the Recovery budget.

Application process will consist of:

- 1) Submission of application
- 2) Provide documentation requested below

Confidentiality

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance to be provided. It will not be shared with other parties for any other purpose.

Disbursement of Funds

To provide for a reasonable and equitable distribution of funds, assistance will be provided on a first come, first serve basis upon completion of application process by qualified applicants. All grants are contingent upon the qualification of the applicant and the availability of funds.
